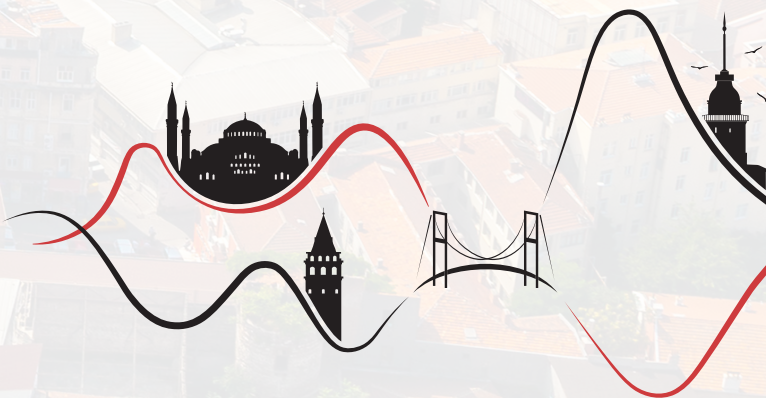

## 1. VAT

Where appropriate, Value-Added Tax (VAT) is applicable to all goods and services offered by the Sponsorship Chairs and all prices in this document are inclusive of VAT. VAT is calculated at the date of publication of this document. The Sponsorship Chairs reserve the right to vary the quoted prices in accordance with any movements in the legislated VAT rate.

## 2. Booking & Invoicing

Sponsorship will be allocated only upon receipt of a signed Booking Form together with these Terms & Conditions. A letter of confirmation will be provided to confirm the booking, together with a **pro forma invoice** for 100% of the fee. The fee is payable **within 14 days** from the date of the pro forma invoice. The **official tax invoice** will be issued to you **in the month in which the event takes place**.

## 3. Currency

All monies are payable in **United States Dollars (USD)**.

## 4. Payment Condition for Listing

All monies due and payable must be received by the Sponsorship Chairs **prior to the event**. No organization will be listed as a sponsor in any official Congress material until full payment and a completed, signed booking form have been received by the Sponsorship Chairs.

## 5. Cancellation Policy

a. **(Postponement)** In the event of postponement by the ICSV32 Organizing Committee, all sponsorship bookings will be carried over to the revised Congress dates.

b. **(Cancellation by Organizers)** In the event of cancellation by the ICSV32 Organizing Committee, all sponsorship payments will be fully refunded.

c. **(COVID-19 implications)** Should a sponsor's attendance at the Congress be impacted by any restrictions enforced by COVID-19 government regulations, the ICSV32 Organizing Committee will discuss the available options on a case-by-case basis and reach a mutual agreement with the sponsor.

d. **(Cancellation by Sponsor)** In the event of cancellation by the sponsor (other than as a consequence of any restrictions enforced by COVID-19 government regulations), the following cancellation fees will apply:

(i) **More than 60 days** prior to the Congress (**May 5, 2025 and earlier**): **50%** of the total payment due will be applicable.

(ii) **From 59 days** prior to the Congress (**May 6, 2025 and later**): **100%** of the total payment due will be applicable.

Should a cancellation be made prior to payment, the appropriate cancellation fee will still apply, and the Sponsorship Chairs will issue an invoice which will be payable within seven (7) days. After space has been confirmed and accepted, any reduction in exhibition space is considered a cancellation and will be governed by this cancellation policy. All communication regarding cancellation must be made **in writing**. A reduction in space may result in relocation of exhibit space at the sole discretion of the Sponsorship Chairs. **Any space not claimed and occupied before midnight on March 31, 2026 may be reassigned without notice or refund.**

## 6. Assignment/Subletting

(iii) if a delay or failure by such Party to perform its obligations is caused or anticipated due to Force Majeure, the performance of such obligations will be **suspended**.

(iv) if such delay or failure exceeds thirty (30) days, the other Party may immediately terminate this Agreement by providing written notice to the affected Party.

b. If the Congress is delayed, postponed, altered, or cancelled by a Force Majeure event:

(i) neither Party will exercise a right or remedy under this clause unless and until the Parties have endeavored to agree upon amendments to this Agreement for the delay, postponement, alteration, or cancellation of the Congress; and

The **official tax invoice** will be issued **in the month in which the event takes place**.

## 3. Currency
